5. Report from Malawi

Jack Etete outlined limitations on monthly Outreach Clinic work due to lack of funding. However regular clinics have been held at Mkombe Village, and last month was successful due to a one-off donation from Amanda Ruler which allowed purchase of more pharmaceuticals. The medical firms were previously donating near-expired medications but this is no longer occurring, so the medications have now to be purchased. Jack is using the monthly donation from Zoe Foundation to maintain supply of hypertensive and diabetic medications to a number of regular patients.

Jack expressed thanks for the funding from Zoe last month which allowed purchase of a replacement vehicle.

A property has come on to the market at Salina, 20km north of Lilongwe, which has been used as a tourist lodge. Jack feels this would provide an ideal location for the Zoe Medical Clinic and a base for Outreach Clinics.

Patients could be charged a fee which would raise money for the running of the Centre, Nursing Salary, Laboratory Technician and funding of Outreach Clinics. Jack has spoken to an Accountant and also his Bank Manager. However the bank will not provide funding for start-ups.

Discussion ocurred regarding the need for a Business Plan. There would be a financial need for initial renovations as well as Council Rates and other running expenses. Perhaps an approach to International Aid Agency such as Oxfam may be an option.

Jack mentioned the original idea last year of building a Zoe Clinic near to Jack's home with production of bricks having been undertaken. The previous Clinic location had to be relinquished due to increase in rental and is now located temporarily at NorthWest Mission.

Jack's current contract with Partners In Hope Hospital will continue until December 2024.

David will research the web for a suitable business plan template. Jack will enquire from Oxfam Malawi regarding their position on local health funding. Catherine will enquire with the Australian Communities Foundation regarding business plans.
